- **6.** Capital Expenditure The Proper Officer has an agreed budget of up to £5000 for the purchase of selected items to improve the facilities and offering in the Village Hall Additional funding may be required for item **iv** (below) as the budget does not include provision for storing the bowling mats
 - i. Storage Facility To discuss and approve a course of action.
 - ii. In the light of concerns raised by a resident, a review of the purchase of a plastic shed from Costco & other options has been undertaken by the Clerk.To discuss and approve a course of action.
 - iii. Sound proofing/curtains for main Hall Quotes Etc. from Millenium Interiors.
 - iv. Bowling Mat Solution To further discuss & agree a course of action for the storage of the Bowling Mats currently situated in the store room in the Village Hall.
- 7. Additional Village Hall Committee Members To ascertain interest and agree a course of action and time scale for creating new positions on the Village Hall Committee. Then to advertise/promote and record interested applicants for non-council appointments.
- **8. Defibrillator Update & Training** To discuss the current state of the defibrillator installation and to consider the training schedule offered (at cost) by a local resident.
- 9. Exclusion of Press & Public It was resolved to exclude the public and press owing to the confidential nature of the business to be transacted.

- ii. **Kickstart Scheme -** To consider using the government backed "Kickstart" Scheme to fill fixed term positions to assist with regular community activities and the re-opening of the Village Hall Café and to agree actions.
